1. SPONSOR: The SCONZA Golden Ticket Private Factory Tour Contest (the "CONTEST") is sponsored and administered by Sconza Chocolates One Sconza Candy Lane Oakdale, CA 95361-7899 (the "SPONSOR").
2. ENTRY PERIOD: Contest entries must be received between 9:00 a.m. to 5:00 p.m. Pacific Standard Time ("PST") on May 21, 2022, or May 22, 2022. All entries must be received by 5 p.m. PST on May 22, 2022. All entries must be completed in-person at the Oakdale Chocolate Festival at the SCONZA booth.
3. ELIGIBILITY: Must be 18 years or older at the time of entry. SCONZA will not provide travel accommodation or reimbursement to Contest winners. Employees and their immediate families, including household members, of the Sponsor, its affiliates, subsidiaries, divisions, advertising, and promotion agencies and anyone involved in the production, development, implementation, administration, or fulfillment of this Contest (collectively, the "Contest Parties") are not eligible. Void where prohibited.
4. HOW TO ENTER: All entries must be completed in-person at the Oakdale Chocolate Festival at the SCONZA booth. Entrants must complete an entry form provided at the SCONZA booth and opt into the SCONZA marketing newsletter. One entry per person.
 - 4.1. Visit the SCONZA booth at the 2022 Oakdale Chocolate Festival located in Oakdale, California on May 21, 2022, to May 22, 2022.
 - 4.2. Fully complete the Golden Ticket Private Factory Tour entry form available at the SCONZA booth which enrolls entrants in the SCONZA marketing newsletter. One entry per person.
 - 4.3. Once you click submit, you will be automatically enrolled to receive the marketing newsletter and be entered into the Contest.
5. Entries become the property of Sponsor upon receipt and will not be acknowledged or returned. Contest Parties are not responsible for lost, late, misdirected, corrupted, or incomplete entries. The Sponsor is not responsible for lost, late, or misdirected mail, printing errors, server unavailability, or computer or any other electronic or telecommunications malfunction. Proof of submission is not proof of receipt by Sponsor. Entries generated by a script, computer programs, macro, programmed, robotic, or other automated means are void and may be disqualified. Entries submitted by Entrants

who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. For purposes of the Contest, an on-line form submission is “received” when Sponsor’s website’s servers record the entry information. Proof of sending (such as an automated computer receipt confirming entry or “thanks for entering” message) does not constitute proof of actual receipt of an entry for purposes of the Contest. Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified.

6. PRIZES: There will be 3 Winners who will each win the following:
 - 6.1. A private tour of the SCONZA Chocolate Factory in Oakdale, CA located at One Sconza Candy Lane Oakdale, CA 95361.
 - 6.2. Contest winners will be notified 7-14 days following the end of the Contest via contact information provided by the entrants. Tour will be scheduled between the Sponsor and winners. No travel reimbursement will be provided.

7. DRAWING AND WINNER NOTIFICATION: Prize winners will be determined by a random drawing from all eligible entries received by the end of the Entry Period. Drawing will occur on or about May 30, 2022. The random drawing shall be conducted by Sponsor, whose decisions are final with respect to all aspects of the Contest. The winner will be notified through email or other contact information (as provided on his/her entry form) within seven (7-14) business days of the drawing. Winner will be required to complete, sign, and return a Non-Disclosure Agreement (NDA) provided by SCONZA, within seven (7) business days of receipt of prize notification, or the prize may be forfeited. If prize notification is returned as undeliverable or the winner fails to return the release as specified, the winner will be disqualified, and an alternate winner may be selected.

8. GENERAL CONDITIONS/INDEMNIFICATION: By participating in the Contest, each Entrant agrees to be bound by these Official Rules and instructions and by all decisions of the Sponsor. By participating, Entrants and winners, agree to release, discharge, indemnify and hold harmless the Contest Parties, and each of their respective directors, officers, employees, agents, successors and assigns, from and against any claims, damages, costs (including attorneys’ fees) losses, fines, injuries (up to and including bodily injury and death), or liability due to any damages, losses, or injuries to any person (including death) or property of any kind resulting, in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of a prize or participation in any Contest-related activity or participation in this Contest. Winners assume all liability for any injury or damage caused or claimed to be caused, by participation in or use of the prize. Any false information provided within the context of the Contest by any Entrants or winner may result in the immediate elimination from the Contest or forfeiture of any prize. Acceptance of prize constitutes permission to use winners’ names, cities and states, voices, portraits, pictures, likenesses, footage, entries, essays (if applicable), opinions, and biographical information for promotional purposes in any and all media (including on Sponsor’s social media sites and website) and manners throughout the universe, in perpetuity, without further compensation or permission, except where prohibited by law. The Contest Parties are not responsible for technical, hardware, software, or telephone malfunctions of any kind, lost or unavailable network connections, or failed, incorrect, incomplete, inaccurate, garbled or delayed electronic communications caused by the user or by any of the

equipment or programming associated with or utilized in the Contest or by any human error which may occur in the processing of the entries in this Contest. In the event the Contest is compromised by virus, bug, unauthorized human intervention, or other causes beyond the control of Sponsor that corrupts or impairs the administration, security, fairness, or proper play of the Contest, Sponsor reserves the right, in its sole discretion, to suspend or terminate the Contest and award the applicable prizes from among all eligible entries received by the date of the compromising event that were not damaged or destroyed. The Sponsor reserves the right at its sole discretion to disqualify any individual that tampers or attempts to tamper with the entry process; violates the Official Rules; or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Sponsor reserves the right, in their sole and absolute discretion: (a) to modify, suspend or terminate the Contest should causes beyond Sponsor's control corrupt or interfere with the administration, integrity, operation, security, or proper play of the Contest; or (b) to disqualify any entrant found to be, or suspected of: (i) tampering with the entry process or the operation of the Contest; (ii) acting in violation of these Official Rules; or (iii) acting in an un-sportsmanlike manner. All questions concerning the construction, validity, interpretation and enforceability of these Official Rules and the rights and obligations of entrants shall be governed by California law, without regard to its conflicts of law principles.

9. PRIVACY POLICY: Information collected by Sponsor in connection with this Contest may be used by Sponsor and shared with third parties involved in administration of the Contest in accordance with the SCONZA Privacy Policy. The entrant agrees to the collection, processing, and storage of his/her personal data by Sponsor and/or Administrator for the purposes of the Contest.

10. END OF OFFICIAL RULES
